*Description of Type Design Change:*

Removal of passenger configuration interior items and installation of a cargo door on the forward left hand side of the fuselage, cargo restraint bulkhead at station 300, heavy duty flooring, class "E" cargo compartment, cargo pallet restraint system, and provisions for two (2) additional crew members in accordance with FAA sealed Rosenbalm Aviation, Inc. (RAI) Drawing List No. 6, Revision AA dated June 28, 1988, or later FAA approved revision.

*Limitations and Conditions:* The approval of this change in type design applies basically to the above model aircraft only. This approval should not be extended to other aircraft of this model on which other previously approved modifications are incorporated, unless it is determined by the installer that the interrelationship between this change and any other previously approved modifications will produce no adverse effect upon the airworthiness of that aircraft.
